Agrees as follows:

1. Consignor shall make all sales of items located on the premise, those listed on the shoppe registry, ebay, any other internet venue including and not limited to shoppe website, theDollieBoudoirDollShoppe.com, Ruby Lane, Bonanzle, Ebay or any area doll show or sale events behalf of the Consignee whichever is appropriate and stated below.
2. Consignor shall charge Consignee 25% on any sale.
3. Consignee shall be charged 3.5% on all credit card, debt card or Paypal transactions.
4. Consignee shall be charged any online listing and/or final fees costs, if applicable.
5. All state and local sales tax is the sole responsibility of the Consignor.
6. Consignee will receive their sales proceeds mailed within 10 business day from the day funds clear the bank.
7. Consignee shall provide the Consignor with an updated inventory list at all times that shall include and not be limited to: 1) Item number for inventory purposes, if applicable; 2) description of item including any damage; 3) price and 4) lowest starting price for eBay, if applicable.
8. Items placed for sale in the shoppe shall be at the discretion of the Consignor and must be dolls and/or doll related and of good quality. Consignor has the right to reject any items deemed inappropriate for the shoppe.
9. Consignee agrees to keep Consignor free of harm from theft, fire, damage or breakage of items and shall hold Consignor safe from any and all liability therefrom.
10. Indemnity Provision: Consignee shall indemnify and keep Consignor free of any harm, loss, or cost (including statutory liability and workman's compensation laws liability) in connections with claims for damages as a result of injury or death of any person or damage sustained to any property by Consignee or any other person which arise from or in any manner grow out of any act of neglect on or about The Dollie Boudoir Doll Shoppe/Karen A. Kosies or its partners, agents, landlords, employees, customers, invitees, contractors and subcontractors.
11. Governing Law: This agreement shall be governed in accordance with the laws of the State of Arizona.
12. Either party may terminate this agreement with 30 day written notice to the other party.

13. Items left in shoppe longer than 30 days after the termination of this agreement, without proper notice or contact, shall be considered abandoned and shall become the sole possessions of the Consignor.
